The undersigned (Thereinafter called the “Applicant”) hereto applies for membership in and agree to purchase electric energy from the Samar I Electric Cooperative, Inc. (hereinafter called the “Cooperative”, upon the following terms and conditions:

1.

The Applicant shall pay to the Cooperative the sum of (P 5.00) PESOS which, if this application is accepted by the Cooperative will constitute the applicant’s membership fee.
2.

The applicant shall, when electric energy becomes available from the Cooperative electric energy used in the premises described below and will pay therefore electric bills to be determined from time to time in accordance with the by-laws of the Cooperative
3.

The Applicant shall cause his premises to be wired in accordance with wiring specifications approved by the Cooperative.
4.

The Applicant shall comply with and be bound by the provisions of the charter and by-laws of the Cooperative, and such rules and regulations that may from time to time be adopted by the Cooperative, and all provisions in the contract.
5.

The Applicant binds himself, agrees, and waives any rights to further notice after having been served, directly or indirectly, a bill for his electric consumption and failure to pay on time or for any violation of any rules and regulations as indicated in the preceding paragraph, before disconnection of the service is made.
6.

The Applicant, by paying a membership and becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the law his private property is exempt from execution for any debts or liabilities.
7.

The undersigned shall grant to the Cooperative as its request the necessary right-of-way easement without cost or condemnation by the Cooperative for erection, maintenance and operation of the Cooperative’s equipment the right to cut or trim such tree the Cooperative may deem necessary to construct, operates, replace, repair and perpetually maintain, on the property including other properties apart from the property when service is applied for connection , owned by the undersigned, its lines for the transmission or distribution of electric energy, and will execute and deliver to the Cooperative any conveyance, grant or instrument which the Cooperative shall deem necessary or convenient for said purposes for any of them. All lines of the Cooperative and switches, meter and other appliances and equipment constructed or installed by the Cooperative on said property shall at all times be the sole property of the Cooperative to operate, maintain o execute at its option.
8.

The Cooperative shall at its option deny service for refusal of Applicant to sign a right-of-way easement to disconnect an existing service for refusal of Applicant to sign a right-of-way easement on properties owned by the Applicant other than the premises, as cited in preceding paragraph, where service is extended by the Cooperative.
9.

The Cooperative shall not be liable for damages to the applicants for failure to supply electricity to said premises under any condition.
10.

The acceptance of this applicant by the Cooperative, shall constitute the agreement between the Applicant and the Cooperative, and the contract for electric service shall continue in force for one (1) year from the date service is made available by the Cooperative to the Applicant and thereafter as long as the Applicant has need for any electric service on the subject premises.

This application when duly signed by the applicant and duly approved by the Board of Directors serve as the contract between the applicant member and the Cooperative.

APPLICATION FOR ELECTRIC SERVICE CONNECTION

Location \_\_\_\_\_

The undersigned (hereinafter called the APPLICANT) hereby make application to the SAMAR I ELECTRIC COOPERATIVE, INC., (SAMELCO I) hereinafter called the COOPERATIVE for all electric energy required to be use in the premises referred to above. Upon acceptance of this application by the Cooperative, APPLICANT agrees as follows:

- 1. Electric energy shall be taken and used in accordance with the APPLICANT will comply with and be bound by the provisions of the Articles of Incorporation and by\_ Laws of the COOPERATIVE, and the rules and regulations as may from time to time be adopted by the Cooperative.
- 2. The APPLICANT will pay monthly to the Cooperative at its office for all electric energy furnished hereunder in accordance with the by-Laws of the Cooperative and the rules and regulations as may from time to time be adopted by the COOPERATIVE. Provided, that the COOPERATIVE may limit the amount of electric energy to be furnished for industrial purposes.
- 3. The APPLICANT shall perform his rights and responsibilities as a member of the COOPERATIVE.
  - a. The APPLICANT has the right to receive fair and transparent billing for electric service provided by the COOPERATIVE.
  - b. The APPLICANT is entitled to safe, reliable, and uninterrupted electric service.
  - c. The APPLICANT has the right to be informed about the proper procedures for service disconnection.
  - d. The APPLICANT has the right to receive adequate customer assistance for queries or issues, and clear procedure for handling complaints.
  - e. The APPLICANT has the right to dispute any service-related issues and to be provided a formal mechanism for dispute resolution.
  - f. The APPLICANT has the right to access information related to rates, policies, planned service interruptions, maintenance schedules, and any changes that may affect their service.
  - g. The APPLICANT is obligated to receive monthly bills from the COOPERATIVE.
  - h. The APPLICANT agrees to pay all bills for electricity service promptly and in full, including any fees, charges, and taxes levied by the COOPERATIVE.
  - i. The APPLICANT is responsible for using electricity in a safe and responsible manner, ensuring that electrical appliances, installations, and systems are operated according to safety standards.
  - j. The APPLICANT agrees to maintain their electrical system within the premises in good condition, ensuring that wiring, meters, and electrical devices meet the safety and technical standards.
  - k. The APPLICANT agrees to cooperate with the COOPERATIVE and any other authorized personnel in matters related to electric service.
  - l. The APPLICANT is required to pay a bill deposit as a security for the COOPERATIVE in the event of non-payment, as specified by the Cooperative’s guidelines.
  - m. The APPLICANT agrees to pay any billing adjustments determined by the COOPERATIVE, such as adjustments for inaccurate meter readings, estimated bills, or any previous undercharging/overcharging corrections.
  - n. The APPLICANT agrees not to engage in illegal or unauthorized use of electricity, including but not limited to electricity pilferage or any act of tampering with the electric meters or wiring.
  - o. In the event that there is a need to correct previous bills due to billing errors or discrepancies, the APPLICANT is obligated to pay any differential billing amounts arising from such corrections.
- 4. The COOPERATIVE is expressly authorized and empowered to remove its property and discontinue furnishing electric energy should the APPLICANT fail to comply with any of the rule and regulations of the COOPERATIVE for electric energy and for this purpose shall give all the necessary rights of entrance to access upon and exit from said premises.
- 5. The APPLICANT agrees to maintain the wiring installation within the premises in the proper and safe condition throughout the life of this Agreement and to notify the COOPERATIVE of any change in load.
- 6. The APPLICANT likewise agrees to provide a protective box for the said meter at the above said premises and be held responsible for loss or damage of said meter and other electric accessories owned and furnished by the COOPERATIVE in connection with the application.
- 7. The APPLICANT shall be held responsible liable for tampering, interfering with or breaking of seals of meter or other equipment of the COOPERATIVE installed on the APPLICANT premises and/or for any of the unlawful acts defined and enumerated under *Section 2 and 3 of the Republic Act No.7832.*
- 8. The APPLICANT shall be held responsible and liable for any of the existence and presence of the circumstances defined and enumerated under *Section 4 of Republic Act No. 7832.*
- 9. The parties hereto have agreed that the contract shall be deemed subject to the provisions of the Republic Act No. 7832 otherwise known as the *Anti-Pilferage of Electricity and Electric Transmission Lines Material Act of 1995.*
